TRSA Expedited Hygienically Clean Certification

- 1. Pre-Audit Evaluation determine suitability for certification
- 2. Program Design and Application
 - Complete and submit TRSA Hygienically Clean Application (including payment of application fee)
 - Assign Key person(s) to complete "Producing Hygienically Clean Textiles" e-learning course.
 - Begin program development and QA manual build with consultant.
 - Conduct wash formula and finishing (drying, ironing, packaging) program review with your consultant. Precise guidance on effective programs per type of machine will be provided.
 - Collect initial samples and send to selected 3rd party lab for baseline evaluation
 - Review and adopt all OSHA compliance up to and including BBP (Blood Bourne Pathogens –
 Universal Precautions) safety procedures, signage and training This will include all aspects
 from soil sort, plant housekeeping, wash formula monitoring. Logs will be provided to monitor
 key areas and activities to validate compliance
 - Work with your consultant to complete your company branded QA manual and OSHA compliant training programs
 - Conduct training of key managers or local training (Production, maintenance, transportation etc.)
 - Continue sample collection and lab assessment of textile items When 2 sets of samples pass microbiological testing, you've completed the e-learning course, and your critical compliance list is substantially complete your consultant will recommend you for Preliminary Certification.
- 3. TRSA to evaluate consultants report and issue preliminary certification under the following conditions:

Application and fees paid

Consultant's report submitted

Lab report with 2 successful test cycles

Training completed

QA manual and compliance logs in use

Physical site inspection of QA manual, and plant systems will be scheduled when possible.

4. Since physical inspection is not possible at this time, the plant will be subject to the following Preliminary Certification requirements:

Test sample frequency will be monthly for first 4 months

TRSA can order a 3rd party to collect samples with minimum notice

5. In addition to the ongoing testing and virtual inspection, To maintain certification, every plant must agree to a physical inspection of their facility as soon as we 're able to get an inspector to your locations.
